About CLS FAST Program

Since launching in Fall 2013, FAST program cycles have generated more than 8,000 advisory hours valued at over \$1,900,000 for the 84 companies who have been through the program. Since participating in FAST, these companies have raised >\$1.9B and created over 500 new jobs, more than tripling their workforce. Over 30 of these companies have secured Series A and beyond, and 20 have concluded strategic partnerships.

The FAST Advisory Program provides select entrepreneurs with intensive team review and coaching to perfect their business model and product development plans, and to build a compelling commercialization strategy. Experienced entrepreneurs, product, and business experts (which may include clinical development, regulatory, reimbursement and business development specialists) will advise selected Fellows during a twelveweek program.
